Stora Skogsgården is 20 km from Norrköping and Liljeholmen is in Rimforsa, which is 40 km from Linköping. We travel to the camps by bus from Linköping.

The leaders travel on the bus as well, and once the camp finishes, we travel back to Linköping by bus. You will stay with other participants in rooms with 2-4 beds. The leaders also live in the house, but in separate rooms. There is always a leader on hand who you can talk to, even at night, for example, if you have trouble sleeping or need to talk about something. At Liljeholmen other activities run in parallel with our own, but no-one else will be staying at the house with us.

# Youth camps

Organised by Ungdomsarenor/Leisure and Recreation Services (Fritidsverksamheten), which is part of the Section for Resource and Support Activities (Sektionen för resurs- och stödverksamhet) at Linköping Municipality. We have been tasked with running residential camp activities by the Child and Youth Welfare Services Committee (Barn- och Ungdomsnämnden). Camps are an opportunity to provide children and young people with a safe and secure break, but they are also about community, memorable experiences and growing as a person. It can be a big step to be away from home for this period of time. About 3-5 youth leaders work at the camp during each period.

Overall responsibility for the activity rests with a manager and the operational manager.

## Travel to and from camps

People attending camps travel to and from the camp as a group by bus from Linköping.

#### Cost

The cost is SEK 300, which is paid prior to the camp in connection with registration. NB! Registration is binding.
